

More about Waddon

St George's church is centrally located in the large suburban housing estate of Waddon, in the borough of Croydon, with the majority of housing constructed by the local authority between the two world wars. The population is growing with several new housing sites under construction which will add to St George's potential to bring new members to our congregation. The Parish has some social challenges, in terms of working age poverty and people living on their own. The estate is serviced by two primary schools. Aerodrome Academy has a strong and close relationship with St George's (see Appendix A for comments from the Headteacher). Recently, a new primary school, Harris Academy, opened in Waddon and we would like to see a similar relationship develop, as per the Aerodrome Primary.


Waddon has a large GP practice, clinic, dentists, sports centre, and swimming pool. There are many food stores in the area including Wing Yip and a large Morrison's supermarket. Within close proximity there are several large parks including, Waddon Ponds, Duppas Park, Purley Playing Fields and Roundshaw Downs which encompasses the original London Airport. The South London Pirates are one of the most successful teams in the British Baseball Federation, playing on an area adjacent to the old airport buildings.

The estate has great transport facilities including frequent bus services and Waddon railway station which, provides short transit times to central London stations, Victoria and London Bridge. East Croydon station is a transport hub where trams, buses and trains provide services to Wimbledon in the west, Gatwick Airport and Brighton to the south and Cambridge in the north.

The People

St George's offers worship in the broad Anglo-Catholic tradition, in a manner that is inclusive and accessible by the congregation.

On Sunday morning we ring the church bell to welcome our community to our 10 am Eucharist. Sunday services are Common Worship. On Thursday at 10 am we also have a Eucharist (in traditional language).

Within St George's everyone is encouraged to use their gifts within services as fully as possible.



The Community

Our church centre helps us to bring people together and engage with many different social groups such as the weekly Toddler Group. We also have a lunch group on Thursday's and a monthly community breakfast on the 1st Saturday of the month which are open to all. Waddon councillors host their monthly surgeries in our Church and will often join the community breakfast at the completion of their meetings. Our Church Centre is also hired for many social events to engage and support with the local community.



Social Life

St George's has a very active social life with events planned for every month except August. For example, we organise events such as a Race Night, Burn's Supper, Afternoon Tea and a Strawberry Fair. Our events provide an opportunity for everyone in the community to come and experience St George's hospitality and welcome.





The Building

St. George's was built in 1932 and re-ordered in 1985. The building has Grade II listed Arts & Craft interior. The mosaics on the front of the church were created by a local community artist together with local children. The building is generally in good condition and is looked after by the churchwardens and several members of the congregation. The next quinquennial is due in three years. The previous quinquennial inspection, which highlights some areas of work, is available on request.

Context

St George's is part of the Parish of Croydon: St John the Baptist. The Parish comprises two districts, one served by St George's and the other by Croydon Minster. The churches are part of the Croydon Central Deanery. The priest at St George's is known as the Associate Vicar to reflect the fostering of collegial working within the parish.

Next door to St George's is the detached four bed room "church house". It is surrounded by a garden providing a secluded and pleasant family area. The Diocesan Property Department will work on the house prior to the arrival of the new Associate Vicar.

Clergy at St George's are fully reimbursed for expenses and are actively encouraged to take time out, keep their days off and continue personal development!

From the Revd Canon Dr Andrew Bishop, Vicar of Croydon:

I hope you have enjoyed reading this profile and that you are attracted to St George's as an Associate Vicar in this parish.

St George's is an integral part, with Croydon Minster, of the Parish of Croydon and our governance reflects this. The Associate Vicar with responsibility for St George's has incumbent status, and so will chair the St George's DCC, attend the PCC and PCC Standing Committee and, with me and the St George's PSO, be responsible for safeguarding.

The role also includes some liturgical and ministerial tasks and responsibilities in the wider parish, where with me and Fr Michael Walcott (Associate Vicar at the Minster since September 2025) we work in a collegial and mutually supportive manner. Our vision is of three priests, serving two churches in one parish, with clear areas of responsibility on which we lead.

If you come to St George's you will have supportive clergy colleagues and a committed and wonderful group of wardens and laypeople to encourage you in your ministry to them and the wider community of Waddon.
