A small group is also exploring 'Missionary Disciples advocates' for every deanery as we seek to develop as disciples, evangelists and missionaries.

3. Local Vision and Context (taken from the parish profile)

- To come together as a benefice reaching and serving everyone in the village communities.
- To work especially with schools, children and families, to share Christ from churches which are committed to growing younger and more diverse.
- To become churches of missionary disciples, intentionally engaging in deepening faith and discipleship and gaining confidence in mission and evangelism.

The benefice comprises of the parishes of Ashwicken with Leziat & Bawsey, Congham, East Walton, Gayton, Gayton Thorpe, Great Massingham, Little Massingham, Grimston, Harpley and Roydon. Their combined population is 6,548. There are 5 primary schools (Ashwicken, Gayton, Great Massingham, Harpley and Grimston/Pott Row Holly Meadows) which together serve 533 children and their families.

4. Responsibilities

General:

- A. To exercise the cure of souls shared with the bishop in this benefice in collaboration with local lay and ordained colleagues and to have regard to the responsibilities of the clergy (as set out in the Canons, the Ordinal (*listed overleaf), the Code of Professional Conduct of the Clergy) and other relevant legislation.

Specific:

- To lead us in mission and outreach as we seek to live out our calling to share the good news of Jesus Christ
- To discern, encourage and equip vocations
- To help us build on our relationships with our 5 village schools
- To enable the benefice to engage with ways of deepening faith and discipleship
- To develop a strategy for pastoral care
- To lead worship with flexibility, building on connections between the church and the agricultural year
- To encourage us to work across the benefice, while maintaining our individual identities

6. Diocesan New Incumbents Programme

The Diocesan Mission & Ministry department offers two training events for those new to incumbency in the Diocese. Both are residential courses, one on skills for incumbency and one on new incumbency, more focused on person in role.

The Archdeacons of the Diocese are also reinstating the diocesan new incumbents' induction programme following the pandemic.

1. *From the Ordinal

‘Priests are called to be servants and shepherds among the people to whom they are sent.

With their Bishop and fellow ministers, they are to proclaim the word of the Lord and to watch for the signs of God’s new creation.

They are to be messengers, watchmen and stewards of the Lord; they are to teach and to admonish, to feed and provide for his family, to search for his children in the wilderness of this world’s temptations, and to guide them through its confusions, that they may be saved through Christ for ever.

Formed by the word, they are to call their hearers to repentance and to declare in Christ’s name the absolution and forgiveness of their sins.

With all God’s people, they are to tell the story of God’s love.

They are to baptize new disciples in the name of the Father, and of the Son, and of the Holy Spirit, and to walk with them in the way of Christ, nurturing them in the faith.

They are to unfold the Scriptures, to preach the word in season and out of season, and to declare the mighty acts of God.

They are to preside at the Lord’s table and lead his people in worship, offering with them a spiritual sacrifice of praise and thanksgiving.

They are to bless the people in God’s name.

They are to resist evil, support the weak, defend the poor, and intercede for all in need.

They are to minister to the sick and prepare the dying for their death.

Guided by the Spirit, they are to discern and foster the gifts of all God’s people, that the whole Church may be built up in unity and faith.’

‘In the name of our Lord we bid you remember the greatness of the trust that is now to be committed to your charge.

Remember always with thanksgiving that the treasure now to be entrusted to you is Christ’s own flock, bought by the shedding of his blood on the cross.

It is to him that you will render account for your stewardship of his people.

You cannot bear the weight of this calling in your own strength, but only by the grace and power of God. Pray therefore that your heart may daily be enlarged and your understanding of the Scriptures enlightened.

Pray earnestly for the gift of the Holy Spirit.’
