

### Role Description: Benefice of Bedlington, Cambois and Sleekburn

#### 1 Introduction

The role description gives an outline of the responsibilities of a position. These may develop while someone is in post and this document will need to be kept up to date. It should be reviewed as necessary at Ministerial Development Review, alongside the setting of objectives.

- 2.1 Role title: Vicar of Bedlington, Cambois and Sleekburn
- 2.2 Name of benefice: Bedlington, Cambois and Sleekburn
- 2.3 Patronage: (1) Durham Cathedral Chapter (2) Newcastle Cathedral Chapter
- 2.4 Deanery and archdeaconry: Bedlington; Northumberland
- 2.5 Initial point of contact on terms of service: The Archdeacon of Northumberland

## 3 Role purpose: General

- 3.1 To share with the Bishop in the cure of souls.
- 3.2 Ever prayerful and mindful of the responsibilities laid upon you in the Ordinal, the Canons, national Safeguarding policies, and all other relevant legislation, in accordance with the Archbishops' statement *Guidelines for the Professional Conduct of the Clergy*, your ministry will be shaped by the Diocesan vision based upon Seeking, Sharing, Sending and marked by a generosity of spirit, an engagement with the people and situations you serve, and an openness to the promptings of God's love.
- 3.3 Your priestly vocation demands the careful preparation for, and the leading of public worship, the imaginative proclamation of the Gospel of our Lord Jesus Christ and the loving service of all God's people entrusted to your care. Together with your priestly colleagues and lay ministers, you will work collaboratively to enable the gifts of all God's people to be developed in the Service of his Kingdom.
- 3.4 In your priestly ministry you will take an active part in the developing Diocesan strategy. This will include collaborative parish conversations and planning for mission and ministry as well as working with colleagues across the Deanery and more widely in the life of the Diocese. A number of supports are available to you through the provision of work consultants, spiritual directors and Continuing Ministerial Formation programs, and you will be expected to participate in the scheme of Ministerial Development Review.
- 3.5 Above all, you will remember that we are called to minister by a gracious, generous self-giving and loving God, as together we seek the Kingdom, share the faith, search for truth, serve our neighbour and follow Jesus in his suffering love for the salvation of all people.



### Role Purpose – Generic and Specific

- 3.6 To take responsibility for pastoral care, occasional offices and leading of regular public worship in the parishes of Bedlington, Cambois and Sleekburn.
- 3.7 To care for and encourage the congregations to grow in faith, in numbers and in service to the community through preaching, leading of worship, teaching, and prayer and to lead the parish in the development of its vision and strategy for growth.
- 3.8 To develop and grow the ministry team across the benefice, recognising the talents and skills of lay people, and where appropriate making links into the diocesan authorised lay ministry initiative in worship and pastoral care.
- 3.9 To bring a mission focus to the wide range of contacts and activities which take place in the life of the church and through the congregation, and support those who lead them.
- 3.10 To encourage and develop existing work with children and young people in the church and build on engagement with local schools, particularly Whitley Memorial Church of England Primary and Bedlington Academy.
- 3.11 To continue work on making all the church buildings in the benefice open, accessible and sustainable.
- 3.12 To engage creatively with the different communities across the benefice. To seek out new missional opportunities and discern potential for new worshipping communities.
- 3.13 To encourage and enable the congregation in the principles of stewardship and financial giving as part of discipleship.
- 3.14 To lead the parish and church community into creative and active partnership with the deanery in a time of change and to be open to closer cooperation with neighbouring parishes in mission, particularly Choppington parish. Active engagement with Deanery Chapter, Synod and the Deanery Development Group is expected.
- 3.15 To be pro-active in ensuring that you continue to access new resources for your ministry and that personal spiritual nurture, refreshment and development is given priority.
