Notes to the Accounts

- 1. The Financial Statements of the P.C.C. have been prepared in accordance with the Church Accounting Regulations 2006 using the Receipts and Payments basis.
- 2. The following assets are recognised but not necessarily valued in the Statement of Assets and Liabilities; Moveable Church Furnishings held by the Church Wardens on special trust for the P.C.C. which require a faculty for disposal.
- 3. The expenses paid to Clergy may include a small immaterial proportion which relates to their function as P.C.C. members. No other member of the P.C.C. received any payment for being a member of the P.C.C.
- 4. The transfer of Planned Giving from the Stewardship Fund of £9,677 is included in the Unrestricted Voluntary Income figure of £26,382 in the General Fund.
- 5. The Stewardship Fund has been prepared through figures supplied by its manager.
- 6. It is assumed that the figure quoted for Unrestricted Petty Cash comprises of the cash float and involces/receipts not yet passed to the P.C.C. Treasurer for re-imbursement totalling £50 and cash float £5 for Sunday AM Tea/Coffee.
- The General Fund total of £28,516 includes the sum of £2,867 which relates to small Restricted Funds.
